# **Financial Report**

### - Hugh Crawley, Treasurer

- 1. 2021 Financial Statements were audited by Scarrow & Donald, in accordance with MHC bylaws and the appointment of the auditor approved at the 2021 AGM.
- 2. General account balance was \$115,616.04. as of December 31, 2021 (the end of our fiscal year) and \$96,128.29 as of March 31, 2022. On March 31, 2021 the General Account had a balance of \$155,409.79; however this was due to an influx of emergency funding in March 2021.
- 3. Audited statements show an overall difference of \$17,773 between revenues and expenses (in the negative).
- 4. Covid-19 had significant effects on the 2021 fiscal year but government stabilization funds permitted us to remain in a reasonable financial position.
- 5. The facility had more use in 2021 than 2020 resulting in increased revenue (\$40,580 in 2021 vs \$14,792 in 2020). It is anticipated that rentals will further recover in 2022.

### continued

- 6. Received Covid support through various government programs in the amount of \$93,534 during 2021. \$40,000.00 of this was distributed to clubs via community grants.
- 7. Slight drop in club membership income but an increases in individual membership income in 2021 over 2020.
- 8. Core funding remained stable for 2021.
- 9. Continued to invest in the facility in 2021 with \$26,137 showing as invested in capital assets.
- 10. We have incurred increased labour costs.

The single biggest issue in 2022 will be ensuring we stay on budget and maintain control of spending with the end of emergency pandemic support.

Ensuring memberships and facility rentals return and exceed prepandemic levels will be essential for maintaining financial stability.

# Registered Coach Status- Winter Fair

Effective January 1, 2022, Coach Status became mandatory for all equestrian coaches delivering EC sanctioned programs or activities and Registered Coach Status (RCS) mandatory at all EC sanctioned events.

For Winter Fair, MHC gave each Manitoba Licensed, Registered and Pending Coach a lanyard and badge showing their status.

Out of province coaches requested the same badges which were also provided.

Badges were initially well-received; however, in the absence of clear direction from EC about enforcing the RCS mandate, coaches stopped wearing them.

MHC is waiting to hear from EC regarding plans for identification and enforcement of RCS going forward
