Clinician - Dr Billy Wiltshire

Dr Billy Wiltshire has been riding since he was 5 years old. He started out in South Africa and took part in Pony Club, show jumping and horse trials, mostly re-schooling Thoroughbred ex-race horses. He moved to Winnipeg, Canada 21 years ago and continued in the jumper ring with off-the-track Thoroughbreds. His current competition horse is a 5 year old former race horse that he started last year.

Billy is an Equestrian Canada Senior Jumper judge and has mentored several aspiring Jumper judges who have shadowed with him over the last 8 years.

In October 2017 he was honoured to be invited to judge the Young Jumper Performance Series in Johannesburg, South Africa. He has also judged in BC as well as Manitoba.

Billy was president of the Manitoba Hunter Jumper Association for over 10 years and still sits on the board as Past President. Billy considers himself to be a "serious hobby rider" and his motto is "Life without horses would simply be ONE BIG MISTAKE"
